



NEW YORK STATE-APPROVED DRIVER EDUCATION FOR HIGH SCHOOL STUDENTS—FALL 2018

PLEASE READ THIS IMPORTANT INFORMATION:

Applications will be accepted beginning on March 5, 2018. You do not need your Learner Permit to apply, however, a photocopy must be submitted to this office no later than September 7, 2018.

Applications are processed in the order in which they are received.

Applications received after August 6, will only be accepted if space remains.

Course Information

- This 16-session program includes 24 hours of classroom instruction, plus homework, a midterm and final, and 24 hours of group driving instruction (four students per car), including observation, with each student spending 6 hours behind the wheel over the course of the program. It is expected that students practice driving outside of class with their parent/guardian.

Enrollment Requirements

- You must be a high-school student who resides in the Great Neck school district, be at least 16 years of age by September 7, 2018, and have a copy of your Learner Permit on file in our office no later than September 7, 2018. If you have not made arrangements to obtain a Learner Permit (once you have turned 16), please refer to the New York State Department of Motor Vehicles Web site for detailed information at www.dmv.ny.gov.

Application Procedure

- The application must be completed and signed by a parent or guardian and include payment and all requested information (see deadlines above). **You may submit the application before receipt of your Learner Permit; however, a copy must be received by September 7, 2018, as indicated above.**
- Complete the enclosed application and mail/email/fax to the above address. Registrations are accepted on a first-come, first-served basis until August 6. Be sure to indicate **3 choices** for both car and theory classes. If you do not indicate 3 choices, and we cannot accommodate your choice, your form will be returned. **Spaces are not held by phone: registration cannot be completed by phone.**
- Space in the program is limited; once the maximum is reached, registration will be closed. Therefore, it is to your advantage to file your application as soon as possible, even if you have not yet received your Learner Permit.
- Application for a New York State Learner Permit at the DMV (once you have turned 16), requires presentation of legal forms of identification, including an *original* social security card and *original* birth certificate. Be sure to have these documents with you when you go to the Motor Vehicle office or you will be turned away, and issuance of your permit will be delayed. Be sure that you give yourself ample time to obtain your permit before the start of classes. **Please be sure to view all requirements on the New York State DMV Web site, www.dmv.ny.gov.**
- **If a copy of your Learner Permit is not received by September 7, 2018, you will be dropped from the program, and your fee will be returned. It is your responsibility to make sure we have received it. Please take a photo of the front, and email to: gncontinuinged@greatneck.k12.ny.us.**
- Tuition is \$575. Payment may be made by check or money order (payable to Great Neck Public Schools) or by major credit/debit card. On withdrawal before the start of the semester, a refund minus \$30 will be

issued. **Once the semester begins, there will be no refund.** If you qualify for reduced lunch, you must include the GNPS confirmation letter with your application.

Attendance

- **Attendance at all Driving Groups and Theory Classes is mandatory. According to State Law, any absence and/or lateness must be made up. Unexcused absences may result in dismissal from the program. Please be sure you can attend and be on time for all sessions before you register. Team practices and games and/or other school activities are not excused absences.**
- **If driving or theory class is canceled due to school district closure or instructor absence, a makeup session will be provided. If a student is absent from class, he/she is responsible to discuss makeup availability with the theory teacher or car instructor.**

Upon Completion

- Students who successfully complete the requirements for this non-credit course will receive a Student Certificate of Completion (MV-285), which includes an Insurance Premium Reduction certificate. This form, issued on the last day of the program, allows students to make a road test appointment. After receiving the MV-285 and passing the road test, a 17-year-old is eligible for a full, New York State senior license; a 16-year-old is only eligible for a junior license, with restrictions. Without completion of a state-approved Driver Education program, a NYS senior license is not issued until age 18.

Location & Transportation

- **All Theory Classes are held at 30 Cumberland Avenue.** Bus transportation is provided from North and South High Schools at 3:30 p.m. and at 5 p.m. to arrive in time for Theory classes, at 4 p.m. and 5:30 p.m. classes. Transportation home by bus at 5:30 p.m. is provided from Cumberland. Students. **Students must provide their own transportation on Saturday and at 7 p.m. from Theory Classes.**
- **Private and parochial high school students** who are residents of the Great Neck school district may attend Driving Groups leaving from South High, North High, or Cumberland and Theory Classes at Cumberland; however, no transportation is provided.
